SEMINARY SEEKS DEVELOPER FOR AFFORDABLE HOUSING ON CAMPUS

Recently Pittsburgh Theological Seminary completed a facilities master plan, and the Board of Directors approved that plan during the May 2018 Board meeting. This plan included a recommendation to pursue options concerning Seminary-owned apartment buildings on the corner of North Highland and Stanton Avenues—Highlander, Anderson, and McMillan. Trends in theological education point to increasing numbers of part-time and commuter students and changes in expectations for on-campus housing. For many years, the majority of residents in PTS housing have been non-PTS students. Those reasons, coupled with the age and conditional assessment of the buildings, led the Seminary to consider the disposition of these apartments. This decision is linked to the overall theme of the master plan as well as two of the plan's general goals:

Master Plan Key Theme: Strengthen the Core – Develop the Edge

Right-size the buildings and grounds to meet anticipated need and efficiently utilize the space

Address expected future residential housing needs and aging apartment buildings

During the May 2019 Board of Directors meeting, the Board approved a motion whereby a request for proposals (RFP) be released in order to solicit and entertain offers to purchase and repurpose these buildings into affordable housing for the neighborhood and Seminary students.
