



# PTS WELCOMES NEW BOARD MEMBERS

Pittsburgh Theological Seminary has elected five new members to its Board of Directors— Angel De La Cruz, K. James Evans, Lisa Franklin-Robinson, Donald McKim, and Susan Vande Kappelle. They will begin their service to the Seminary in June 2014. Additionally, Sandra Lamb replaces John Isherwood as chair of the Board.



The Rev. Dr. **Angel De La Cruz** '98/'07 earned his M.Div. and D.Min. from Pittsburgh Seminary. In 2003, De La Cruz was the organizing pastor of an independent multi-ethnic church which became a new church development, Word Centered Presbyterian Church, in the Shenango Presbytery. It was the first new church charter development in Shenango Presbytery in 102 years. De La Cruz has also served as a chaplain for the State Correctional Facility in Pittsburgh and at Heartland Home Health in Hermitage, Pa. Additionally, he serves on the Seminary's Metro-Urban Institute Advisory Council.
