## RETURNING MATERIALS

After hours, drop off materials in the Book Drop just outside the entrance

## NEW MATERIALS

Items on the "New Materials" display have the same loan period for every patron type. New materials have a 4-week loan period, no renewals, and are subject to overdue fines of \$0.25/day.

## PRIVILEGE LENGTH

Library privileges for clergy, general public, and reciprocal borrowers will expire one year from registration. When your account has expired, contact the front desk at **412-924-1354** to renew for another year.

## PTS RECIPROCAL BORROWERS

PTS students and faculty are granted access to resources at our reciprocal borrowing partner institutions (linked below). Visitors to these institutions receive limited borrowing privileges, which are stipulated by the individual libraries. Different institutions have different procedures for receiving a reciprocal card, but it is advised that students are prepared to provide both a campus ID and a valid driver's license or state-issued ID. PTS students and faculty are also granted access to select libraries nationwide through the Atla Reciprocal Borrowing Program.

## \*NON-PTS RECIPROCAL BORROWERS

Barbour Library welcomes students and faculty from our reciprocal borrowing partner institutions (linked above). A driver's license or state-issued ID and a valid campus, university, or institution ID is required.

All library policies and campus rules must be followed. A reciprocal borrowing card will be issued and is to be retained and used by the specified borrower only.
