

# EXECUTIVE CERTIFICATE IN RELIGIOUS FUNDRAISING

# **APRIL 18-21, 2016**

Pittsburgh Theological Seminary and Lake Institute on Faith & Giving are partnering to offer an executive certificate in religious fundraising. Held April 18-21, 2016, the four-day event is designed for persons with leadership positions in faith-based nonprofit organizations or churches. The onsite course will teach students about raising money in religious organizations, with focus on churches, nonprofits, and religious social service organizations.

The Executive Certificate in Religious Fundraising program provides the research, tools, and training to meet the growing needs of religious leaders to inspire and transform philanthropic giving within their congregation and community. Sessions include Nurturing Generous Congregations and Organizations, Fundraising as Ministry, Nurturing Generous Donors, and Shaping a Theology of Money. Upon completion of the courses, participants will design either a year-round stewardship program or annual-giving (fundraising) program, including an



evaluation of the program upon completion. Upon completion of this program, the Executive Certificate in Religious Fundraising will be awarded.
